#### [I Spy...The Red Flags in Preschoolers](#)

Participants will be able to identify the growth and developmental milestones of children birth to five years old and recognize potential red flags, receive instructional support, develop strategies, acquire individualized instructional support for children identified with potential special needs and learn how to include children with special needs in their classroom activities. Attendees will have the opportunity for group discussions, interactive conversations as well as engage in small and large group activities. After this training, providers will be better equipped to identify growth and developmental red flags, be confident on how to address the concerns with caregivers and where to refer the child for further evaluation. ### Health and Safety Training for Child Providers

The State Board of Education has approved [Rule 6M-4.620, Health and Safety Checklists and Inspections](#). This rule requires at least one Health and Safety inspection annually for all child care providers who contract for School Readiness. It is anticipated the rule will take effect on or around October 24, 2016 and Health and Safety inspections of School Readiness providers will begin mid-November 2016.

The Office of Early Learning has scheduled five training and guidance webinars for School Readiness providers and their staff to explain and discuss the new regulations. The dates and times for the webinars are listed below. The same information will be shared on each webinar, so please only register for one of the scheduled times.
