Dear Friends:

In the month of September I had the opportunity to travel to Washington, D.C. with a small Florida delegation that included the leadership of both the Florida Chamber of Commerce and the Greater Miami Chamber of Commerce. We met with members of Congress from both sides of the aisle and also had an opportunity to address several members of the administration. Although every member of the Florida delegation had a specific set of priorities, our collective message was simple: We are all working together to support economic development in Florida.

More and more the business community understands that our work focuses on early education and supports working parents and economic development. This understanding of our work has not come easy. Children's Movement of Florida



Led by a 27-member committee of influential Floridians, the Children's Movement of Florida has announced a statewide, citizen-led, non-partisan series of "Milk Parties" on behalf of Florida's children. The sweeping series of 15 "Milk Party" rallies will be conducted throughout Florida between Sept. 6 and Sept. 30, beginning in Pensacola and ending in Key West. The goal is to attract substantial media coverage.

The events will include appearances by movement leaders, children's advocates, entertainers and local celebrities and supporters. Refreshments will include milk and cookies. A bus called "The Children's Express" will carry the group on "The Children's Movement Road Tour" from city to city. No public funds are being used.

The objective: To educate political, business and civic leaders - and all parents in Florida - about the urgent need to improve the way we care for our children, making the well-being and education of our youngest and most vulnerable citizens, Florida's highest priority. The need is clear: By almost every objective standard, Florida ranks poorly in measure after measure of how we invest in children.


Through the sheer magnitude of these rallies and the thousands of supporters who attend them, the aim is to show influential leaders in Tallahassee and everywhere else that we have the power to obtain for Florida's children the resources they require and deserve. Team Member Spotlight

This month, the spotlight shines on another valued team member and the important work she accomplishes in

bringing quality early childhood education to our community. In this issue, it is our pleasure to highlight **Belinda Jeanty-Gauthier**, VPK Monitor.

Belinda Jeanty-Gauthier has been an ELC team member for over five years. She joined the Coalition as an assessment specialist, a position in which she administered several environmental rating and program administration scales, and completed high-stakes classroom assessments in various socio-economic settings. Also, she assessed the quality of early childhood education programs according to NAEYC standards for locally- and federally-funded grant and quality initiative pilot programs.



In her current capacity with the ELC, Belinda serves the community as a VPK monitor, overseeing monitoring responsibilities in the northern region of Miami-Dade County for more than 300 pre-schools and early childcare centers participating in the Voluntary Prekindergarten (VPK) program. She provides technical assistance to VPK centers and low-performing sites in the areas of improvement plan and goal setting, lesson planning, curriculum selection and training, room arrangement, and self-evaluation checklists.

Belinda is fully aware of the vital role the ELC plays in the lives of South Florida's young children, "Being part of an organization that believes *every* child should have a fair start in their education and works to constantly level the playing field by encouraging and facilitating high-quality programs is what drives me," she says. It is through Belinda's work in the field however, where she sees firsthand how the mission of the Coalition comes to life, "It is so gratifying to visit a center for a second time and see the center's renewed commitment to quality and how the classroom environment and the children's portfolios have dramatically improved as a result of the recommendations that were given during a previous monitoring visit."

In previous professional positions Belinda served as a research analyst and writer for a nationally-recognized public opinion and political consulting firm. There she was a project manager for the first national study of Haitian-Americans. Additionally, she directed a project to analyze the role of female juveniles in the Dade County Criminal Justice System as a University of Miami research fellow.

In her time outside of the ELC, Belinda enjoys reading, traveling, and spending time with her family and close friends.

School Readiness (SR)

Child Screening and Assessment Update

Welcome back to school year 2010-11. The Early Learning Coalition in collaboration with Miami-Dade County Child Development Services will continue providing an annual developmental screening for every school readiness child with signed parental consent. The results of the screenings are helpful in determining if a child is developing typically, may be at risk for delays and/or should be referred for further evaluation.

The Ages and Stages Questionnaire (ASQ) will be mailed monthly beginning in September as school readiness children will be screened in their birth month rather than all at the same time. This should ease the burden on teachers having to complete many screenings in a short period of time. Additionally, there will be no need to determine which ASQ a child will need; it will be the 12-, 24-, 36-, 48-, or 60-month questionnaire. At the beginning of each month centers will receive the ASQs in the mail. They should be completed immediately and returned by the 20th of the month. A self-addressed envelope in which to return the completed questionnaires will also be provided.


The Children's Express bus will roll into Key West as part of a statewide campaign to encourage the people and
