

Florida Releases its Employment Figures for February

For February 2011, Florida's Agency for Workforce Innovation (AWI) reported that the State's seasonally adjusted unemployment rate is 11.5 percent which is slightly below the January 2011 rate of 11.9 percent.

Agency for Workforce Innovation Director Cynthia R. Lorenzo believes that while Florida's unemployment figures are still unacceptably high, the positive signs that employers are beginning to hire and consumers are feeling more optimistic about the State's economic recovery show the workforce system is getting back on the right track.

School Readiness (SR)

ASQ Screening Reminder

Providers: Please be sure you are returning your ASQ screenings to Miami-Dade County in a timely manner. ASQs are due back at the end of respective children's birthday months (for example, if a child's birthday is May 9th then his or her ASQ must be returned by May 31st). Provider Contracts Must be Returned by May 15th

The 2011-12 Provider Contracts (Agreements) have been mailed to providers. The contracts are due back to the Coalition by May 15. A new policy approved by the Coalition Board of Directors requires all providers receiving school readiness funding to be licensed as of July 1. The exceptions to this requirement are Miami-Dade County Public School programs that are operated and supervised by school personnel; religious exempt programs and informal providers. Voluntary Prekindergarten (VPK)

VPK Summer 2011

If you are a current VPK provider for the school year program all you need to submit are AWI VPK Forms 11 A & B. If you are a *first-time applicant* this school year you must submit AWI VPK Forms 10, 11 A & B, and the Provider Agreement. We strongly encourage providers to submit their applications by email to their respective VPK certification specialists at the ELC. Further instructions will be provided at a later date as we develop your online account.

VPK School Year 2011-2012

ALL VPK providers for the school year program should submit the new AWI VPK Forms 10, 11 A & B, Provider Agreement, and Attachment A. We strongly encourage providers to submit their applications online. Look for more information in the next news flash regarding the application period and upcoming trainings on completing the forms.

Final 2009-2010 Readiness Rates Have Been Released

2009-2010 final Readiness Rates can be viewed at http://vpk.fldoe.org. Any provider with a score below 140 is listed as an LPP. To complete an acknowledgement of your score, please log into the website using your ID and password. Please note that the survey is only regarding your VPK program and not your business as a whole.

You will also be required to complete an improvement plan. You can obtain additional information and/or clarification by attending one of the following meetings for Low Performing Providers. Please contact Elizabeth Machado at 305-646-7220 ext. 229 to reserve a space at one of the sessions.

2011-2012 VPK School Year Registration begins in April

Registration for the upcoming 2011-2012 School Year Program begins with a series of round-ups:

Saturday, April 9; 10:00 a.m. - 1:00 p.m. Wesley House Family Services, 1304 Truman Ave., Key West

Saturday, April 16; 9:00 a.m. - 12:00 p.m. Murray Nelson Government Center, 102050 Overseas Hwy., (MM 102 Bayside), Key Largo;

Saturday, April 16; 3:00 p.m. - 5:00 p.m. Holiday Inn Express, 13201 Overseas Hwy., (MM 53 Oceanside), Marathon

Ongoing registration for the School Year Program begins on Monday, April 18 at all Wesley House locations from 9:00 a.m. - 4:00 p.m. (Monday - Friday in Key West and Tavernier; Tuesday and Thursday in Marathon). Children must be 4-years-old on or before September 1, 2011 to participate in the 2011-2012 School Year Program.

2011 VPK Summer Program Registration is Underway

Registration for the Summer Program is ongoing at all Wesley House locations from 9:00 a.m. - 4:00 p.m. (Monday - Friday in Key West and Tavernier; Tuesday and Thursday in Marathon). Children who have not previously participated in VPK and will be entering kindergarten in the upcoming 2011-2012 school year are eligible for the Summer Program. The 300-hour Summer Program runs from June 14 - July 26 from 7:45 a.m. - 5:30 p.m.

The three potential Summer VPK sites are **Key Largo School**, **Marathon High School** and **Poinciana School in Key West**. Parents must provide transportation.
