New Process for DCF Background Screenings

On August 1, 2012, the DCF Background Screening Office became centralized and is no longer emailing or mailing clearance letters to Child Care providers. Providers must now register to get access to the DCF web portal where they will have 24-hour access to view and print the letters they need. Once registered, the provider will see an applicant's screening results, which will be available for 90 days.

DCF has established a BGS Help Desk, where providers can either reach a representative or a voice mail message. The voice mail message will give providers another link to immediate help if they cannot get through to the Help Desk.

The Department of Education has extended the deadline to submit results from Assessment Period 1 from Oct. 12 to Oct. 28.

VPK providers may report any problems they are experiencing with the VPK Assessment Online Reporting System by sending an email to vpkassessment@fldoe.org and including the following information:

- Center/school name, address, and phone number
- Provider ID (4- or 5-digit number)
- Name of person reporting the problem
- Username and password
- Description of issue

Social Emotional Development Awareness Day

Mayor Carlos A. Gimenez and the Miami-Dade Board of County Commissioners proclaimed Saturday, Sept. 22, 2012, as Social Emotional Development Awareness Day. About 420 providers participated in the Social Emotional Development Awareness Day Pyramid Model trainings held across Miami-Dade County, an increase of more than 50 participants from 2011. Several agencies partnered with ELC staff to provide these trainings, including Miami-Dade County; Family Central, Inc.; Florida Diagnostic Learning and Resource System (FDLRS); Technical Assistance & Training System (TATS); and Citrus Health Network.



The Spanish session held at the United Way was attended by 82 providers.

The Children's Trust Family Expo



Florida Releases Its Employment Figures for August

Florida's seasonally adjusted unemployment continued at 8.8 percent in August 2012, unchanged from July. There were 818,000 jobless Floridians out of a labor force of 9,261,000. Nationally, the unemployment rate was 8.1 percent in August. The region's unemployment rate is down to 9.3 percent.

The unemployment rate for Miami-Dade County was 9.4 percent, 2.0 percentage points lower than the rate a year ago. Monroe County was 5.0 percent, still the lowest percentage in the state, and 1.5 percentage points lower than the year-ago

rate of 6.5 percent.

ELIS: Early Learning Information System

Provider Management Design Info

Here are some things you should know about the ELIS design for provider management. ELIS will include a lot of self-service featuresthings providers will be able to do for themselves.



Attendance Submission & Processing

Providers will be able to complete and submit child attendance on-line each day; or all at once at the end of the week or the month. ELIS will double-check every entry as it is made. Online attendance will eliminate entire categories of errors by making them impossible. Processing attendance by coalition staff will be faster, easier and far more accurate-automatically.

Providers Will Be Able to Maintain Their Own CCR&R Profiles Online

Providers will be able manage and update their own CCR&R profiles using the Internet and the ELIS Provider Portal. This self-service feature will allow providers to keep their profiles current themselves, although some items will require coalition verification before they will be included in the profile.

Child Enrollment Automation

ELIS will automatically add new child enrollments to the correct provider's attendance sheet as soon as placement is completed. This will ensure attendance is tracked from the moment of enrollment and that new children will not be overlooked. Improvements like these will eliminate many of the causes of prior period adjustments, will enable more accurate provider reimbursement forecasts, and reduce the workload on coalition staff. Providers will be able to initiate a customer or provider transfer online.

Licensing News and Updates

From the Desk of Suzette Frazier, Regional Safety Program Manager Department of Children and Families Child Care Licensing



This section of the News Alert is designed to inform and remind providers of the licensing requirements of the Department of Children & Families. This licensing corner is a new and innovative way for providers to stay connected to childcare licensing and will serve as a guide to new regulations, information about recalls, licensing updates and much more.

The Background Screening Web Portal offers providers 24/7 access to view and print all screening detail for employees - results and public records - received within

the last 90 days. Providers are able to:

- View and print screenings for employees:
 - Who have cleared screening
 - Who need to contact DCF
 - Who are disqualified
 - Whose fingerprints were rejected
 - Who need to submit additional information
- Search for clearance letters for screenings completed by other providers that are no more than 90 days old. If the screening results are more than 90 days old, the provider can contact the HELPLINE at 850-717-4454.

HOW TO ACCESS RECORDS:

- Go to the Background Screening Home Page at <u>www.dcfbackgroundscreening.com</u> and select WEB PORTAL LOGIN.
- Log in with your username and password. NOTE: If you do not have a
 username and password and want to create an account, click the above
 link. Select CONTACT US and submit an email requesting your account.
- Once logged in, click on the BACKGROUND SCREENING tab to enter the portal.
- Click on MY PROVIDER SCREENINGS. This automatically displays a list of screening results for your facility/program within the last 90 days.
